Qualifications for Voting

The voters shall be baptized persons of full age, domiciled in the parish or adjacent thereto, of good moral character, adhering to this Church and to no other religious body, regular attendants at the services of this parish, meaning thereby those who are more frequently present than absent, and regular contributors to the current expenses of the parish for 6 months before the annual meeting. Any voters not baptized or confirmed in the parish shall have been received as communicants in accordance with the Canons of this diocese or shall be baptized persons who have been received on their written request to the rector or to one of the wardens if there be no rector. No one shall be permitted to vote or be eligible for office in more than one parish in this diocese. The rector or wardens shall keep a list of all who have been received as voters, which list shall be open to inspection by the members of the parish. The chairman of the meeting shall be the judge of the qualifications of voters.
